Volunteer hereby agrees to defend, indemnify and hold harmless the Santa Rosa County Fair from and against any claim, demand, suit, loss, cause of action, damages, liabilities, obligations, costs, (including attorney's fees and costs), expenses, and judgments (including without limitation, personal injury or death and damages to property) caused by Volunteer's acts or omissions or the negligence, as described in the above paragraphs, of the Santa Rosa County Fair, including all those described in the preceding paragraphs, or not.
