

GENERAL RULES

(www.SRCFair.com)

1. Unless specified under the Division, there will be a limit of one entry per person in each class.
2. All exhibits entered for competition must have been made, grown or Constructed/Designed since the 2015 fair.
3. All Entry Forms should be submitted as soon as possible. The deadline for submitting an entry form is one week before the Fair's opening day. All exhibitors who do not submit an entry form as specified may be allowed to display their exhibits only if space is available, but they will not be judged nor eligible for any award. All entries must be brought to the fairgrounds between 3pm - 9pm on Thursday All work must be in place before the close at 8:00pm on March 31st and remain in place until 10:00 pm April 9th. Work must be picked up by 4:00pm April 10th.
SRC Fair is not responsible for work left after this time.

4. **All Exhibitors** must sign in at the welcome table that will be at the front entrance of the exhibit hall
5. The Santa Rosa County Fair Association is not liable or responsible for damage, breakage, theft, etc., for any items at the Fair. However, efforts will be made to protect them.
6. Early removal of any item is not allowed and any premium money won will be forfeited.
7. All judging will be independent, and the Fair will not participate in judging. All judging will be completed on Friday, April 3rd and ribbons in place by opening at 5:00pm Consult the specific sections for each division for rules and judging information.
- 8 Exhibit spaces are 8 feet wide by 8 feet deep. Height limits are maximum 4 feet sides and 6 feet back. 4-H Exhibit spaces are 8 feet wide by 4 feet deep. Any exhibitor who wishes to utilize additional space must request it on the exhibit entry form and have approval from the Exhibit Committee. All oversized exhibits will be judged in a separate category and are not eligible for Special Premiums.
9. The Competitive Exhibits Hall will be closed nightly between 9:00 & 10:00 p.m. during the length of the fair.
10. Each exhibitor is required to clean around his/her exhibit daily.

11. Sound amplification equipment will not be permitted unless written permission is granted by the Fair. Such equipment could be subject to removal if improper use is cited. If electrical power is needed for an exhibit, this need must be clearly stated on the entry form and approval granted by the Fair management. All electrical cords must meet safety standards and be placed out of the way of passersby.

12. Management reserves the right to remove from the fairgrounds any articles, exhibits, including banners and advertising materials, that may be deemed objectionable, which action shall exonerate the management from any and all claims whatsoever, on the part of the exhibitor.

13. No giveaways, gifts, drawings, contests, etc., will be allowed without the consent of the Fair without first furnishing in writing to the Fair management complete details of list of prizes and how contest will be conducted. A list of winners will be submitted to the Fair and drawing will be held prior to closing of Fair.

14. Security will be provided; however, the Fair is not responsible for theft or damage to/or from any exhibitor, or injury to any person while at, in or around any exhibit.

15. Liability--Exhibitors will hold harmless, the Santa Rosa County Fair Association, Inc., its members, officers, or its employees, from any act of God, and accidents or mishaps directly connected with the operation of our organization, or exhibit during the Fair.

16. Exhibitor claim checks can be shown at the pass gate after 8 p.m. only to gain entry to the grounds for taking down exhibits. All exhibits should be removed by 4:00 p.m. on Sunday, April 9th.

**No vehicles will be parked inside the fairgrounds without explicit permission.
No vehicles will be allowed inside the fairgrounds until the fair is officially closed.**
